

MISCELLANEOUS OPERATIONS POLICIES (May 2023)

I. PERSONAL MEDIA DEVICES

In order to preserve the natural setting of Indralaya and encourage relationship-building, we ask participants to limit their use of personal devices—including cell phones, tablets, iPods, computers and the like—to non-communal areas such as an individual's cabin or tent. Taking photographs is allowed. (December 2019)

II. WEDDINGS AND SPECIAL EVENTS

Weddings, memorials, and other special events may be held at Indralaya as a benefit of long-term Membership. The details of small, minimal camp-resourced events may be negotiated by management. Larger events using more camp resources and facilities require Board approval. (March 2020)

III. PERSONAL RETREATS

Membership in Friends of Indralaya is required for personal retreat. (October 2018)
Management is authorized to schedule personal retreats for members.
Day use of the property for members may also be scheduled at the discretion of the management team.

IV. GROUP RETREATS

Group retreats closed to the public that include a connection to and benefit to the community of Indralaya are permitted with Board approval. Retreats will be screened by the Program Committee and presented to the Board for approval, either in person or via email. (June 2018)

V. BOATS

Campers may launch their own watercraft (inflatables, paddle boards, wind surfers, kayaks, canoes, and row boats) from the dock (Note: the dock was damaged by adverse weather becoming unusable effective 2022 program season) or Near or Far East beaches. Campers must exercise the same care as they would in using any other access to East Sound, including following all US Coast Guard regulations. (March 2020)

VI: DIETARY GUIDELINES

Indralaya Meals (updated March 12, 2022)

Policy Statement

Indralaya has been vegetarian since its beginning days in 1927, a decision founded on the theosophical recognition that we are all part of an interconnected web of life. The meals we serve reflect our mission to honor and engage with nature in ways that cause the least harm and that foster compassion. To that end, we grow and purchase organic produce that is locally sourced as much as possible, and we serve vegetarian and vegan meals.

Website Statement

Indralaya serves vegetarian and vegan meals, using organic produce from our garden and organic, local ingredients as much as possible.

VII: SMOKING

Smoking and the use of tobacco products including e-cigarettes or nicotine vapor products are prohibited on Camp property. (December 2014)

VIII: CAMPER SPONSORSHIP

Anyone under 18 must be accompanied by a parent or guardian to visit Indralaya. An on-site Sponsor, age 26 or older, may fulfill this role. Sponsorship must be approved by management prior to arrival and sponsorship forms must be completed prior to arrival by both a parent/guardian and the sponsor. (March 2020)

IX: BORROWING CAMP EQUIPMENT

The camp will not loan any camp owned materials or equipment to anyone. (October 2018)

X. PUBLIC NUDITY

Nudity is prohibited in all shared and public spaces. Nudity is permitted at beaches only with consent of adults and/or guardians of any children present. If children or other adults arrive, consent must be obtained for nudity to continue. (December 2019)
